Notice of Adoption of Local Plan and Adoption Statement

Regulation 26 Adoption of a Local Plan

Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended)

In accordance with the above Regulations, this Adoption Statement gives notice that East Sussex County Council, South Downs National Park Authority and Brighton & Hove City Council (the Authorities) formally adopted the Waste and Minerals Sites Plan (the Plan) on 7 February 2017.

The Plan provides the spatial details for the requirements contained within the Waste and Minerals Plan which the Authorities adopted in February 2013. The Plan identifies potential locations for future waste management facilities and safeguards existing waste and minerals resources to 2026.

The Plan was subject to Public Examination by an independent Inspector in August 2016. A consultation on the Main Modifications to the Plan was subsequently held between 26 August and 7 October 2016. The Inspector's Report was issued on 7 November 2016 and can be viewed at the locations set out below and on the following website:

A person aggrieved by the Plan may make an application to the High Court under the Planning and Compulsory Purchase Act 2004 section 113 on the ground that:

- (a) the Plan is not within the appropriate power;
- (b) a procedural requirement has not been complied with.

The application must be made not later than the end of the period of six weeks starting with the date the Plan was adopted. The period ends on 23 March 2017.

The Plan cannot be questioned in any legal proceedings except in so far as is provided by section 113.
